

Visitor Rules

- 1. Valid ticket must be presented for admission to the exhibition. Visitors may be required to provide identity proof upon admission.
- 2. Tickets and other entitlements are non-transferable, non-exchangeable, non-refundable, not for re-sale, and void if altered.
- 3. The last admission time is 30 minutes before closing.
- 4. For security reasons, surveillance cameras are used at the public areas in the exhibition.
- 5. Strollers, wheeled luggage, carriers, and recreational devices (such as skateboards, scooters, inline skates, and shoes with built-in wheels) are not allowed. Please keep all personal belongings by yourself, this exhibition does not provide storage service, the organizer will not be responsible of any damage or loss.
- 6. Mobility aids for people with disabilities (such as wheelchairs, crutches, walkers, canes, prosthetic devices, and other orthotic devices) are allowed. Personal medical equipment is also allowed.
- 7. No washrooms are available at the exhibition hall.
- 8. Dangerous or hazardous materials are prohibited, including flammable and corrosive substances; cans or objects which may pose risk to any person or property; firearms, ammunition, or offensive weapons of any kind; and objects that resemble weapons.
- 9. Please do not bring inflated balloons into the exhibition. It is also prohibited to fly a kite, drone, or model aircraft inside the exhibition.
- 10. Children below the age of 12 must be always accompanied by an adult.
- 11. Smoking or vaping is not permitted on the show premises.
- 12. The sale or display of any goods or services is not allowed, except with the written approval from the Organizer.
- 13. The distribution of flyers and any other marketing materials is subject to authorization. Unauthorized distribution will result in the visitor being asked to leave the exhibition and removal of all materials.
- 14. Please do not touch, move or lean against any exhibits unless specifically allowed. A safe distance should be maintained from all exhibits, cases, platforms, and pedestals.
- 15. Eating and drinking are prohibited in the exhibition.
- 16. Please do not graffiti, damage or touch the exhibits. Please keep the exhibition venue clean and do not litter.
- 17. Please do not run or play inside the exhibition.
- 18. Please do not bring artwork for valuation.
- 19. Unless specified otherwise, visitors are welcome to take photos or videos for personal/ non-professional use without disruption to the exhibition or visitors; however, flash photography, selfie sticks, monopods and tripods are prohibited.
- 20.Except for trained assistance dogs (such as guide dogs, hearing assistance dogs or service dogs), pets and other animals are not allowed in the exhibition. Trained assistance dogs must always wear identifying vests or tags and remain on a leash or in a harness and under the control of the owner.
- 21. Please be respectful to other visitors and our staff.
- 22.Please be mindful of your belongings. The Organizer will not be liable for any lost or damaged items left on the premises.
- 23.We reserve the right to deny admission or to ask visitors to leave without compensation or liability for failing to comply with any of our instructions or engaging in unsafe, illegal, or unruly behavior.
- 24.We may photograph, film, videotape, record or otherwise reproduce the image and voice of any visitor who enters the exhibition and use the same for media, or editorial purposes and may be used on the web, social media platforms, in publications, or as promotional materials. Your consent to such publication is assumed upon your participation to the event/ enterance to the exhibition.
- 25. Each group is limited to enjoy the photo booth once.
- 26. Each customer is limited to purchase one unit per merchant.
